# "7TH INTERNATIONAL NOVEL NATURAL STONE DESIGN COMPETITION" SPECIFICATION

# I. Organization

This Competition is organized by İzmir Fair Services Culture and Art Trade Joint Stock Company (İZFAŞ).

#### II. Aim of the Competition

Approximately 35% of the world's marble reserves are located in Türkiye. Türkiye is very rich in terms of marble variety. Turkey has over 80 different structural types and more than 120 different colors and patterns of marble reserves. As a natural material, marble is widely used in modern architecture today as a cladding and flooring material for both exterior and interior surfaces. In addition, this natural stone—which reflects the beauty of nature—is commonly used in interior applications such as bathrooms and kitchens, in furniture manufacturing, in the production of decorative home accessories and ornaments, and in the construction of monuments and sculptures. Looking at the foreign trade of the sector, Türkiye's natural stone exports amount to approximately 2 billion USD, with a relatively low share coming from processed products. The goal should be to export natural stone not by tonnage, but as processed products with high added value. In this context, the natural stone industry needs innovative, value-added designs and products to increase both its market share and the monetary value of its exports. At this point, the importance of talented designers becomes clear. In light of this information, the main objective of the 8th International Novel Natural Stone Design Competition is to bring young and talented designers into the natural stone sector. With the unique designs and products created by these young and skilled designers, the competitive strength of the industry will increase.

# II. Theme and Targets of the Competition

The theme of the 8th International Natural Stone Design Competition this year has been determined as "NOVEL".

Designers participating in the "Innovative Natural Stone Design Competition" are required to submit projects that involve "DECORATIVE HOME ACCESSORIES" produced from existing natural stone or natural stone remnants. "Single/Standalone Furniture Pieces" will also be evaluated within this scope. Participants are expected to propose any type of high value-added home/office accessory or furniture project made from natural stone and its remnants. Products designed for wet areas (such as bathtubs, sinks, etc.) will also be evaluated within this scope.

The projects are expected to be furniture designs with a contemporary and modern identity that will contribute to global natural stone export.

With this competition, it is aimed to develop high added value, environmental friendly and sustainable furniture projects in the natural stone sector, to contribute to the development and competitiveness of the sector and to contribute to the country's economy. The designs to be made must be product-focused only.

# **III. Participation Category**

# The competition is organized in a single category as a student category.

The competition is open to the undergraduate departments of the faculties of Architecture, Engineering, Architecture and Design, Art and Design, Fine Arts and Design and to the students of other undergraduate and associate degree programs of universities related to design. Candidates who are studying for a master's degree or PhD degree can also apply to the competition as students, regardless of whether they are working or not. In addition, students studying in the preparatory departments of the universities mentioned above can also participate in the competition. Candidates who do not meet the requirements described above and professional designers cannot participate in this competition.

Candidates can participate in the competition individually or as a team. A team can consist of maximum 3 people. In teams, one candidate must be designated as the spokesperson and all candidates must be students. Professionals cannot be included in the team.

Participants are required to upload their student documents to the system during the application process. In order for the competitors, who are expected to graduate within the application dates, to be able to apply by the application deadline, candidates must upload their student documents (Student IDs are not valid) to the system proving that they are students in the Fall Semester of 2025-2026 Academic Year. The date of issue of the candidates' student documents must be between the dates specified for the application (Student cards are not applicable). It is required for the competitors to be students on the date of application for their applications to be valid. Otherwise, the candidates' applications will not be accepted.

#### IV. Terms of Application

1. Candidates can apply to the competition with more than one project. **Candidates must apply separately for each design**. Candidates applying to the competition with more than one design can receive a monetary award once if more than one of their projects is ranked.

- 2. Candidates must be over 18 in order to participate in the competition. Candidates under 18 cannot participate in the competition. Candidates who have previously participated in another competition and won/did not win can participate in this competition. Candidates can participate in this competition with projects that have not won an award in another competition. However, candidates cannot participate in this competition with designs that have won an award in another competition.
- 3. Members of IZFAŞ competition executive committee and the first degree relatives and relatives of the Jury members cannot participate in the Novel Natural Stone Competition. Even if these people participate in the competition and win an award, their awards will be taken back.
- 4. The designs that are submitted to the competition must belong to the applicant, have not been produced and presented to the public before, have not been ranked in another competition / have not received an award / should not be under evaluation in another competition. If the opposite occurs, the design application will be cancelled. In such a case, if the candidate has received an award, the award will be taken back. In other words, if a situation contrary to the commitment occurs during or after the competition, the award of the winner and the expenses incurred, if any, will be withdrawn and the situation is shared with the public. If an award winning design is eliminated from the competition, the next design with the most votes is awarded instead of the eliminated design.
- 5. Candidates will upload their presentation sheets by making their applications at <a href="https://www.degisiktasarimyarismasi.com">www.degisiktasarimyarismasi.com</a>. The application numbers of the candidates will be used as pseudonyms. Candidates will not specify any nicknames on their presentation sheets. Candidates will be able to revise their projects by entering the system with the application numbers given to them until the deadline. Candidates will follow their competition projects with the application numbers given to them. All candidates must upload the documents specified in the specification to the system in full and signed. Applications that do not comply with the specification will be disqualified.

When deemed necessary, IZFAŞ may request the originals of the documents submitted during the application from the participants. The designs of the candidates who do not send the original documents within the given time will not be evaluated.

6. PROJECTS UPLOADED TO THE SYSTEM, PROJECT RELATED TEXTS, FILE NAMES SHOULD NOT INCLUDE CANDIDATE/CANDIDATES' NAMES, IDENTITY/CONTACT INFORMATION, SCHOOL NAME, COURSE NAME, NICKNAME, QR CODE, ETC. Projects of candidates who do not comply with these provisions will not be evaluated. The designer is responsible for all designs uploaded to the system.

- 7. Candidates are required to upload their presentation sheets and documents specified in the specification to the system from the website www.degisiktasarimyarismasi.com until 23:59 on Sunday, 01.02.2026. After this date, the system will be shut down. The competition organization is not responsible for the failure of the uploading of the documents of the designs to the system due to the problems in the upload, the failure to complete the application or the delay. İZFAŞ reserves the right to extend the application date of the competition when it deems necessary.
- 8. If deemed appropriate, İZFAŞ will bring together the designer and the industrialist to produce some of the designs that ranked in the competition and ensure the realization of their production. These manufactured products will be exhibited on behalf of the designer on appropriate platforms.
- 9. Applications from candidates who do not correctly and completely upload all documents required under the 9<sup>th</sup> specification will not be accepted.
- 10. Before uploading their presentation boards to the system, candidates must check the originality of their designs by performing a visual search on the internet using appropriate search engines.
- 11. For designs and boards prepared with artificial intelligence, the competitors must contribute to the work themselves. Designs and boards created solely by artificial intelligence will not be evaluated.

### V. Intellectual and Industrial Property Rights

- 1- Designs violating intellectual and industrial property rights will be eliminated from the competition. Responsibility for all legal initiatives of third parties belongs to the competitor. Even if it is understood after the conclusion of the competition that intellectual and industrial property rights have been violated with the submitted project, the award will be taken back.
- 2- İZFAŞ will have the right to publish, archive (on the website, social media accounts, etc.) the designs for which the application of the Novel Natural Stone Design Competition has been made, and to exhibit it as a product, in case it is produced as a die plate on behalf of the design owner in the country and abroad, indefinitely and free of charge.
- 3. The intellectual and industrial property rights of all candidates regarding the designs belong to the designer himself / herself. It is the responsibility of the participants to take the necessary measures to protect the intellectual and industrial property rights of the designs and İZFAŞ and the organizers of the organization have no responsibility.
- 4. The applicant/applicants of the Novel Natural Stone Design Competition accept and undertake not to make any other changes or transfer, etc. to third parties in the intellectual and industrial property rights of their designs until the award amount is transferred to their own account, except for the registration application and registration in their own name.
- 5. İZFAŞ does not have a request for the transfer of ownership of the designs ranked in the "Novel Natural Stone Design Competition". The ownership of the winning designs in the competition belongs to the designer himself.

VI. Other Provisions

1- Competitors agree, declare and undertake that any information they have obtained during this

competition regarding the competition process, other competitors and İZFAŞ is confidential and that they

will not disclose this information to 3rd parties or use it for any purpose other than the competition. In

case of the detection of a violation of this matter, the awards of the competitors ranking and expenses if

any incurred will be refunded.

2- İZFAŞ has the authority to decide on issues that are not specified in the competition specification when

necessary. In addition, it may extend the application period of the competition. It reserves the right to

change the date and place of the award ceremony. By participating in the competition, the competitors are

deemed to have accepted all these conditions in full. All announcements regarding the competition will be

announced at www.degisiktasarimyarismasi.com.

3- İZFAŞ can announce and publish the information and pictures of the participants, together with the

designs in the format that it deems appropriate.

4- İZFAŞ has the right to cancel the competition at any stage before the result of the competition is

announced.

5- All the participants that signed the competition specification will be deemed to have accepted the terms

of the specification, the conditions of the competition and the decisions of the selection committee.

6. There is a 2-week period to object to the results of the competition from the date the results are

announced. In case of objection to the design/designs, the objection will be evaluated by the jury. If the

jury finds the objection justified, the design in question will be disqualified. If the design has won an

award, its award will be cancelled and taken back.

#### VIII. Application Method

Competition specifications, conditions of participation in the competition and all documents related to the competition will be obtained from the website "www.degisiktasarimyarismasi.com" and this will be done with the presentation sheet and project report to be prepared in digital format for the competition application. **Physical applications will not be accepted.** 

All competitors (in case of team participation, each member of the team must sign separately) must sign each page of the competition specification, participant's commitment and the Clarification and Information Form Related to the Law on Protection of Personal Data No. 6698. Applications can be submitted by uploading the signed specification, participant commitment and information form and the application documents specified in the specification, to the relevant areas of the website.

#### **APPLICATION DOCUMENTS:**

#### 1- Competitor Info

- a) Identity card,
- **b**) Specification, Commitment and KVKK (Law on Protection of Personal Data) document (All pages must be signed and uploaded),
- c) Student certificate for students must be valid as of the design submission date. Student ID cards will not be accepted,
- d) Photograph: Digital passport photograph of the participant
- e) Curriculum Vitae: It should be uploaded to the system in DOC and PDF format including the names, short CVs and contact information of the participants.

#### **2- Project Information**

The project should contain:

#### a) Project Descriptions

- Project name
- Project Report (min. 150 max. 400 words; describing the project in writing, explaining in detail the purpose of the design, the problem it has solved, the innovation it has brought)
- Information on the materials envisaged for the design, briefly the reason for the selection should be explained in maximum 150 characters, and the production technique envisaged for the design should be explained in maximum 150 characters.

# b) Project Sheet:

The project should be explained in 1 presentation sheet. The sheet must be A2 (59.4 x 42 cm) in size, in vertical format, with a minimum resolution of 300 dpi in PDF. In order for the designs to be assessed in detail by the jury, they must be uploaded in the highest possible resolution. There should be at least one or

more visuals on the sheet that describe the functional and aesthetic aspects of the project and how it will be used. It should also include at least one section showing how the project will be implemented and technical details (more drawings can be added if preferred), a view of the design with the user, scaled drawings and brief descriptions.

#### IX. Evaluation Criteria

- Being innovative and original
- Being producible (Designs that are not producible will not be considered for final evaluation)
- Being aesthetic
- Being functional
- Being sustainable

The evaluation process will be carried out in 3 stages.

**First stage;** The projects of all applicants will be evaluated by the jury in a digital environment. During this evaluation process, candidates who pass the pre-selection will be determined.

**Second stage;** The projects that pass the pre-selection will be re-evaluated by the jury within the scope of the evaluation criteria and the design/designers who are entitled to proceed to the production process will be determined. The projects of the candidates who remain in the production process will be re-evaluated within the scope of manufacturability with the participation of natural stone sector representatives and the presentation of the designers. As a result of the evaluation, producible designs will be determined. As a result of this evaluation, the designs that are decided to be produced will be matched with the companies and will advance to the finals. The production of the designs that make it to the finals will be carried out in cooperation with the designer and the company. Non-producible designs will be eliminated during this process.

**Third stage;** The designs that make it to the finals and whose productions are realized will be physically evaluated by the jury at the competition stand on the first day of Marble İzmir Fair, within the scope of the determined criteria and with the candidate presentations, and the ranking of the winning candidates will be determined.

#### Note: FINAL EVALUATION WILL BE MADE ON THE FINISHED DESIGNS.

After the preliminary selection results are announced, the designers of the winning designs and the sector representatives will be brought together in an organization organized by İZFAŞ and a meeting will be held. Only one representative from the students participating in the competition as a team will be invited

to this meeting to represent the team. The production of the products decided to be produced among the winning designs by the sector representatives in this meeting will be carried out by the companies matched with the designers during the meeting. The produced designs can be exhibited by İZFAŞ on behalf of the designer at 2025 Marble İzmir Fair. İZFAŞ's responsibility here is only to bring the designer and the industrialist together.

In-group submissions, the monetary award will be divided equally among the group members.

IZFAŞ reserves the right to make changes to the monetary awards.

#### 2. Production of Designs Award

After the results are announced, the designers of the winning designs and the sector representatives will be brought together in an organization to be held by İZFAŞ and a meeting will be conducted. In this meeting, the production of the products decided to be produced by the sector representatives within the designs that are ranked will be carried out by the companies that match the designers during the meeting. The designs produced can be exhibited by İZFAŞ on behalf of the designer at Marble İzmir Fair. The responsibility of İZFAŞ here is to bring only designers and industrialists together.

#### 3. Design Registration Award

The design registration certificate fee of the first three projects ranked in the competition will be paid by İZFAŞ on behalf of the designer. The design registration process will be carried out by İZFAŞ on behalf

of the candidate. The registrations received will belong to the designer. İZFAŞ shall not have any claim regarding the ownership of the design.

# 4. Holiday Reward

The designer who places in the competition will be awarded a vacation prize sponsored in İzmir Çeşme, one of Turkey's major holiday destinations, consisting of 3 days and 2 nights in a half-board accommodation concept. The sponsor hotel of this competition is "Boyalık Beach Hotel SPA & Thermal Resort". The prize includes accommodation and half-board service. Transportation and all other expenses are the responsibility of the participant. Participants may use this prize either between June 1–30, 2026 or September 1–30, 2026. The prize cannot be used outside of these specified dates. Participants must choose their accommodation date and complete their hotel reservation no later than April 30, 2026. The prize is non-transferable. Unused prizes will be cancelled. This award will be given to the fourth place winners of the competition. In the case of group participation, the prize may be used by a maximum of two people with the mutual agreement of the group members. İZFAŞ's responsibility in this matter is limited to bringing together the designer and the relevant sponsors.

# 5. Internship Award

Candidates who placed first, second, and third in the competition (in case of group participation, the award will be used by one person with the mutual agreement of the group members. If approved by İZFAŞ, all group members may be allowed to use the award) will be provided with internship opportunities at marble companies operating in the Aegean Region, if possible.

#### 6. Software Award

Three students who place in the competition will receive 70 hours of free certified **FUSION 360 and AUTODESK REVIT** training, provided by the software sponsor PROAEC Software Support Services.

#### 7. University Special Award

A 3D printer will be awarded to the university with the highest number of student submissions to the competition. In addition, a faculty member designated by the administration of the first-place university will be invited to İzmir for the award ceremony. For this award, only valid submitted boards will be counted. Projects that are not valid according to the competition specifications will not be considered. A university that has previously won this award cannot receive it again. If a university that has already won this award has the highest number of submissions again, that university will receive only a plaque. The 3D printer will instead be awarded to the university that has not previously won the award and has the highest number of valid submissions under the competition rules.

**Note**: İZFAŞ reserves the right to make changes to the awards.
